Financial Aid Policy & Application 2025/26

Red Cedar School is committed to providing financial assistance to ensure as diverse a student body as possible. The financial aid funds that the school has to offer are raised primarily through the annual fundraising efforts of the families in the school, and through some donations to the school.

The Financial Aid Committee of the Board of Directors attempts to distribute this pool of funds as equitably as possible, according to need. We ask families to pursue every means of raising tuition on their own, including additional employment, support from family, and accessing other resources such as investments and assets, before requesting financial assistance. We will consider a family's ability to generate tuition through their own means in determining financial aid awards.

Financial assistance is also offered in the form of contracted tuition work-off. If the school has a need for some form of work that a family requesting financial aid is able to give, the committee may contract to have the family 'work-off' some of the tuition by helping the school. The help that the school needs most is cleaning the school on weekends. The school also needs professional carpentry and painting at times.

Financial aid is awarded for one year at a time. Families desiring aid for the following year repeat the process. Decisions regarding financial aid are based on many factors, with every attempt made to be as fair as possible. Decisions about awarding aid are the sole judgment of the Financial Aid Committee. Families who feel they need more aid than they are offered in order to attend may ask the Financial Aid Committee to reconsider their situation. All information provided during the financial aid request process will be treated confidentially.
